This email is coming to you in Czech and English, and the English version distributed all over the world by direct email and social media to persons waiting to read this.

The Truth is surfacing all over the world but the blind seems to be leading Czech Government and health policies that are destroying the nation.

Prague, Wednesday 14th October 2020

Hello Health Minister Prymula,

I am a US citizen and if you are wondering why I am writing to you, know that even Washington DC is afraid of me due to past political, economic and legal battles that I won against them. I am a former strategic planner for the Republican National Committee, Washington DC. When Clinton lost both the House and Senate in 1994, I designed and implemented that plan as a civic duty to America.

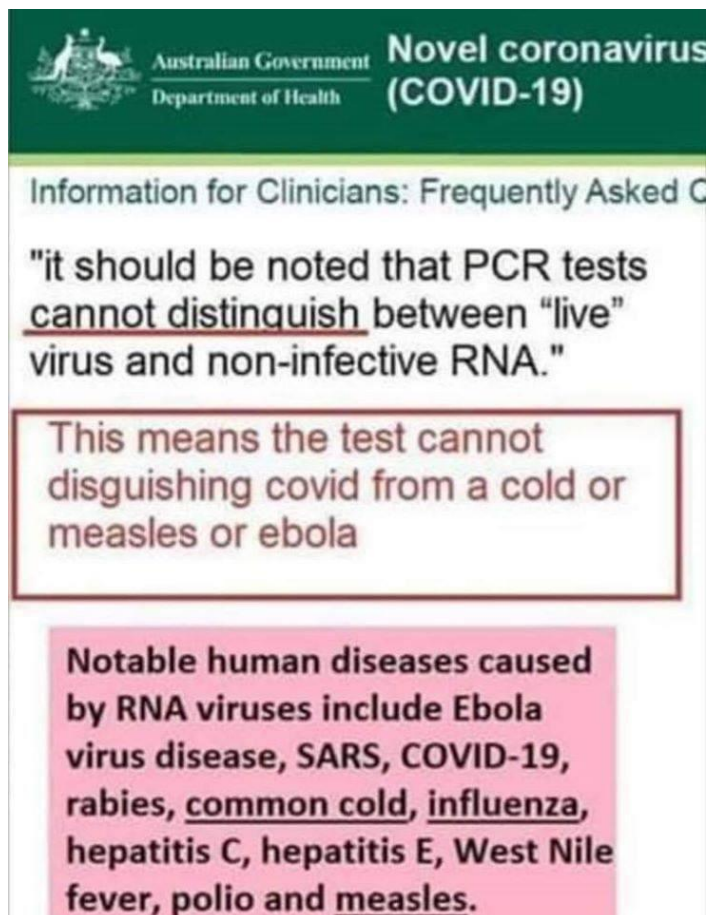

The restrictions will be introduced for a period of 14 days."

Your other Health Ministry edicts valid as of October 12th 2020 are far past absurd. Yes, close down the schools and restaurants again from October 14 to November 3 because your team does not have one damned clue what you are doing. The importance of that is as follows:
